Pasirjambu District) (Lolan and Sutriyawan,2021) . Indonesia included in a third country with prevalence the highest in the Southeast Asia / Southeast Asia (SEAR) region. The average prevalence of stunting under five in Indonesia in 2005-2017 was 36.4%. 3 more from a third (37%) of children under five in Indonesia experienced stunting in 2013 and its prevalence exceeding 40% in 15 of 33 Provinces. WHO target lower stunting rates in children not enough from 5 years namely 40% in 2025. In 2018, East Nusa Tenggara is 42.6 %, West Sulawesi is 42% and Aceh is 35%.
