- Lack of savings People in slums have low salaries and because these people are addicted to it, there is a lack of savings among them.

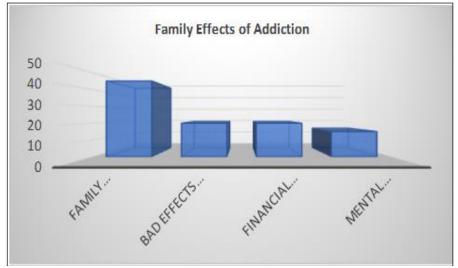


Fig 1 Family Effects of Addiction
